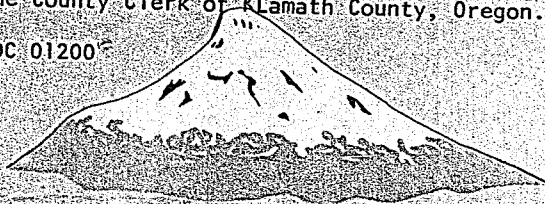


KNOW ALL MEN BY THESE PRESENTS, That KING SEEDS, INC., an Oregon Corporation
