The following improvements, whether on or off the site, are authorized in addition to the residence structure:

Off-lot facilities: Maintaining an off-summer-home-lot water supply system (including pipe line, pump, pump house, and storage tank) for domestic use only. A strip of land approximately 142 feet in length and 2 feet in width to accommodate a buried pipe line between Odell Lake and the south boundary of Lot 2. Driveway.

This use shall be exercised at least 15 days each year, unless otherwise authorized in writing. It shall not be used as a full-time residence to the exclusion of a home elsewhere.
