Department of the Interior, Bureau of Land Management, and WEYERHAEUSER COMPANY,  
a Washington corporation.

W I T N E S S E T H

WHEREAS, on June 19, 1963, the parties hereto entered into Right-of-Way and Road  
Use Agreement RWA No. M-690 recorded in Volume 547, Page 588 in the Deed Records  
of Jackson County, Oregon, and in Volume 346, Page 367 in the Deed Records of  
Klamath County, Oregon, and the United States executed O&C Logging Road  
Right-of-Way Permit (Blanket) (RWA No. M-690). Said Agreement and Permit were

- 2) Prior to construction or use of a road, Weyerhaeuser Company will apply to the respective District Manager administering the respective lands.
- 3) Prior to construction or use of a road, the respective District Manager having jurisdiction of the United States land affected will apply to Weyerhaeuser Company.
- 4) In all other respects, Right-of-Way and Road Use Agreement RWA No. M-690 and O&C Logging Road Right-of-Way Permit (Blanket) (RWA No. M-690) shall remain in full force and effect.


