KNOW ALL MEN BY THESE PRESENTS, That JAYNEEN I. EDWARDS

EDWARDS, hereinafter called the grantee, does hereby grant, bargain, sell and convey unto the said grantee and grantee's heirs, successors and assigns, that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or appertaining, situated in the County of KLAMATH and State of Oregon, described as follows, to-wit:

Lot 6 and the East 4 feet of Lot 5, EAST  
ADDITION TO MALIN, in the County of Klamath,  
State of Oregon.

and that grantor will warrant and forever defend the said premises and every part and parcel thereof against the lawful claims and demands of all persons whomsoever, except those claiming under the above described encumbrances.
