The personal representative is directed to make distribution of the remaining estate property to the person and in the amounts set forth in paragraph 3 above, and the property is hereby vested in that person.

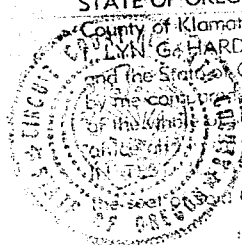
