(Federal Reserve) Public Policy (Charitable) Trust, the Public Money set forth in P.L. 95-147,  
nor pursuant to "jus gentium publicum/privatum", and/or any other laws, codes, statutes, and

I, Sandra Kathleen Byers, the undersigned, currently on inhabitant of the United States of America as a FREE MALE/FEMALE INHABITANT, specifically residing at: P. O. Box 237, Beatty, OR

, do now solemnly state:

I have lawfully submitted my "rescission of contract - in rem" to the appropriate instrumentalities of government. This voluntary act means that I am no longer regulated in commerce under my right to contract (Art. 1 Sec. 10) for the privilege to be so regulated (Art. 1 Sec. 8, Cl. 3) through the unilateral contract: The Birth Certificate, 14th Amendment corporate civil entity.

Therefore, I now voluntarily withdraw from: Dept. of Motor Vehicles: Licensing and Registration System - License #KSL847, Title #8128241123

which is an elective franchise in the Eleemosynary Corporate Estate AKA: The Cestui Que (federal reserve) Public Policy (Charitable) Trust.

With all due authority and ABSOLUTE RIGHTS under the Christian Law of Nations in "jus inter gentus", the Declaration of Independence which is an ordinance within the sphere of the Law of Nations, and the Constitution "for" the United States of America, do hereby serve this REVOCATION OF POWER upon:

LET IT BE CLEARLY UNDERSTOOD: That with reference to the power(s) as heretofore set forth, by whatever device(s), whether known or unknown, by my action(s) or through the action(s) of another, either expressed or implied, are hereby and the same is forever disaffirmed, revoked, cancelled, rescinded, removed, and nullified by this revocation of power(s), and proper NOTICE is given therefore.

Lawful documents of rescission have been served upon the United States Attorney General's Office and upon the State Attorney General's Office. These are key individuals in the Eleemosynary Corporate Trust.

This document/instrument amends and supersedes any and all previously filed and/or declared documentation(s) not in conformity with the terms and parameters hereof.
