ORDER

This matter came on for hearing before the Honorable Donald L. Kalberer on the 8th of December, 1986. Petitioner appeared in person and by and through her attorney, Gilbert B. Feibleman. Respondent appeared in person and by and through his attorney, Donald McCann. The court considered the testimony, exhibits, memoranda and argument of counsel. The court issued a letter opinion on March 3, 1987. Subsequent to the opinion, Petitioner sought reconsideration and clarification by letter. Respondent also wrote the court. On March 17, 1987, the court issued a letter opinion of clarification and reconsideration. NOW THEREFORE,

IT IS HEREBY ORDERED and ADJUDGED as follows:

1. Petitioner is awarded judgment against Respondent for spousal support arrearages in the sum of Twenty-Five Thousand, Eight Hundred and Ten Dollars and 81/100 (\$25,810.81) plus interest at 9% per annum from December 8, 1986.

2. Petitioner is awarded judgment against Respondent for pre-college child support arrearages in the sum of Sixteen Thousand, Eight Hundred and Eighty-Six Dollars and

December 8, 1986.

3. Petitioner is awarded judgment against Respondent  
for college child support arrearages in the sum of Sixteen  
Thousand, Five Hundred and Ninety-Six Dollars and 86/100  
(\$16,596.86), plus interest at 9% per annum from December 8,  
1986.


4. The Court finds that the \$25,810.81 award to  
Petitioner grants Respondent full credit and offset for his  
judgment awarded in the original Dissolution and, therefore,  
Respondent's judgment awarded by Decree of Dissolution dated  
June 9, 1975, nunc pro tunc April 25, 1975, is hereby  
satisfied in full.

5. The Court finds Respondent in contempt of court  
for his willful failure to pay child support. Respondent is  
fined the sum of ~~Two Thousand Dollars and no/100 (\$2,000.00)~~  
One thousand Two hundred two/100 (\$1,200.00)  
which shall be paid to the court.

6. Petitioner is awarded judgment against Respondent  
on account of her reasonable attorneys' fees and costs in
