SUPPLEMENTAL AGREEMENT

THIS AGREEMENT, made and entered into as of the 9th day of January, 1989, by and between WEYERHAEUSER COMPANY, a Washington corporation, herein called "Weyerhaeuser," and STATE OF OREGON, acting by and through its Department of Forestry, herein called "State," WITNESSETH:

RECITALS:

Under date of April 23, 1971, the parties hereto entered into an Easement Exchange, as recorded May 17, 1971, in Volume M71, at Page 4427, Deed Records of Klamath County, Oregon, with respect to certain easements in Townships 37 and 38 South, Range 12 East, W.M. The parties thereto now desire to amend said Easement Exchange, as hereinafter set forth.

NOW THEREFORE, in consideration of the premises and for the purpose of adding to the easements contained in said Easement Exchange, the parties hereto agree as follows:

Weyerhaeuser hereby grants to State a perpetual, nonexclusive easement to construct, reconstruct, use and maintain a road(s) across the following lands owned by Weyerhaeuser:

IN TOWNSHIP 37 SOUTH, RANGE 12 EAST, W.M.

Section 34

Fr. S $\frac{1}{2}$ SE $\frac{1}{4}$

Subject as to said lands to all matters of public record. The location of said road(s) shall be approximately as shown in red on Exhibit A attached hereto.

Except as herein amended, each and every term and provision of the aforesaid Easement Exchange, dated April 23, 1971, as amended, shall be and remain in full force and effect.
