GENERAL DURABLE POWER OF ATTORNEY

PROVIDED, however, that all transactions hereunder for me or for my account shall be transacted in my name, and that all endorsements and instruments executed by my said attorney for the purpose of carrying out the foregoing powers shall contain my name, followed by that of my said attorney and the designation of "Attorney-in-Fact".
