INTC-210.59 SUBORDINATION BY THE GOVERNMENT

The United States of America acting through the Administrator of the Farmers Home Administration (called the "Government") is the owner and holder of the following-described instrument (s) executed by JESPERSEN-EDGEWOOD, INC. (called the "Borrower") of Klamath County, Oregon: Mortgage, dated March 7, 1979, recorded March 7, 1979 in the Microfilm Records of Klamath County, Oregon in Book No. M79, page number 5249.

AND JELD-WEN, inc. (called the "Buyer") has agreed to purchase certain property from "Borrower", the proceeds of which will be used to improve the Government's position with respect to the above-mentioned Mortgage.

THEREFORE, in consideration of Buyer's agreement to purchase such property from Borrower, the Government (1) consents to the Borrower's transfer of an easement in favor of Buyer over and across the real property which is subject to the above-mentioned Mortgage, and (2) agrees to and does subordinate in favor of the Buyer and its successors and assigns its liens or security interests created or evidenced by the above-described instrument (s) insofar as they cover the following-described property:

Buyer agrees to indemnify and defend Seller from any loss, claim or liability to Seller arising in any manner, excepting Seller's negligent acts or omissions, out of Buyer's use of the Easement. Buyer shall pay for any merchantable timber or other property of Seller damaged by Buyer's use of the Easement.
