EXCHANGE DEED

THIS DEED, made this 10<sup>th</sup> day of May, 1988, between the UNITED STATES OF AMERICA, Grantor, acting herein by and through the Forest Service, United States Department of Agriculture, and DAYTON O. HYDE and GERDA V. HYDE, husband and wife, Grantees.

WITNESSETH: That the Grantor, hereunto authorized by the Act of Congress approved March 1, 1911 (36 Stat. 961, as amended; 16 U.S.C. 516) and the Act of October 21, 1976 (90 Stat. 2743; 43 U.S.C. 1715, 1716, 1717), the provisions of which have been complied with, for, and in consideration of the conveyance to it by the Grantee of lands in the County of Klamath, State of Oregon, as stated in the deed to the United States, the receipt of which is hereby acknowledged, does hereby remise, release, and quitclaim unto the Grantee all its rights, title, and interest in and to the real property situated in County of Klamath, State of Oregon, described as follows:

sec. 8, SW1/4SW1/4;

sec. 18, E1/2SE1/4NE1/4, N1/2NE1/4SE1/4, and N1/2S1/2NE1/4SE1/4.

Containing 90 acres, more or less.

TO HAVE AND TO HOLD the above-described real property unto the Grantees, their heirs and assigns forever, together with all hereditaments and appurtenances thereunto belonging.


