## ABSTRACT OF DECLARATION OF TRUST

THIS ABSTRACT is made on <u>FEB 1 3 1989</u>, by LEONA R. CARLSON, who is a resident of Los Angeles County, California, and herein designated as TRUSTOR/TRUSTEE, as follows:

Description of Trust. TRUSTOR/TRUSTEE desires to confirm the establishment of a revocable trust on <u>FEB 15 1989</u>, for the benefit of TRUSTOR and containing (inter alia) the following provisions:

The TRUSTEE has, and shall have, the power to invest, reinvest, purchase, acquire, exchange and sell property for the benefit of the Trust, and to acquire every kind of property, real, personal or mixed, and every kind of investment, specifically including, but not by way of limitation, corporate obligations of every kind, and stocks, preferred or common, mortgage participations, shares of investment companies, bonds, debentures, mortgages, deeds of trust, notes, real estate and mutual funds, which men of prudence, discretion and intelligence acquire for their own account.
