2. Right, title or interest of the public, including governmental bodies in and to that portion of said premises lying below the ordinary high water line of Klamath Lake and



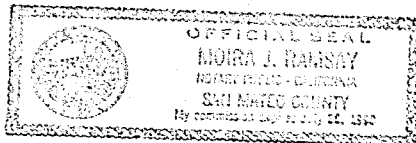
