

## EASEMENT

THIS INDENTURE, WITNESSETH, That KLAMATH COUNTY, a political subdivision of the State of Oregon, herein called "grantor", in consideration of the sum of TEN DOLLARS and other good and valuable consideration paid to it, does hereby grant and convey to LOWELL F. JONES and HARMONY HAWKINS JONES, husband and wife, herein called "grantees", their successors and assigns, a perpetual easement along and upon the following-described property:

A strip of land 30 feet in width, as measured at right angles to the Klamath Falls-Ashland Highway (Oregon State Highway 66), being the southerly 30 feet of the westerly 368 feet of the following-described land, situated in Klamath County, Oregon, to-wit: That portion of the  $W\frac{1}{2}$  and  $E\frac{1}{2}$  of Lot 4, lying North of Highway 66, in Section 1, Township 40 S., R. 7 E.W.M.

This easement shall be for ingress to and egress from and shall run with and be appurtenant to the following-described real property of grantees, to-wit: The W. 330 feet of Government Lot 4, Section 1, Township 40 S., R. 7 E.W.M., Klamath County, Oregon.

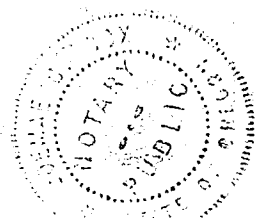
