WHEREAS, the Circuit Court for the State of Oregon for Klamath County, did on the 11th day of May, 1987, make and enter a decree of foreclosure in favor of the State of Oregon, represented and acting by the Director of Veterans' Affairs, against Floyd Hescok; Jessie Lee Hescok, aka Jessie Hatcher Hescok; Pacificorp, dba Pacific Power & Light Company; United States National Bank of Oregon, Klamath Branch; Keith Hescok; and Sandra Hescok, foreclosing them of all their right, title, estate, lien or interest in or to the premises hereinafter described or any portion thereof, on which decree a writ of execution in foreclosure was issued, dated the 16th day of September, 1988, directed to the Sheriff of said county to execute; and by virtue of said execution in foreclosure the lands hereinafter described were struck off and sold to the State of Oregon, represented and acting by the Director of Veterans' Affairs, it being the highest and best bidder therefore, on the 28th day of October, 1988, and the time and place thereof having been duly advertised according to law. PARCEL 1: That portion of the SW $\frac{1}{4}$ of section 24, Township 34 South, Range 8 East of the Willamette Meridian, Klamath County, Oregon, lying Northeast of the thread of the Sprague River.


