KNOW ALL MEN BY THESE PRESENTS, That GARTER ENTERPRISES, INC., an Oregon Corporation,

the grantee, does hereby grant, bargain, sell and convey unto the said grantee and grantee's heirs, successors and assigns, that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or appertaining, situated in the County of Klamath and State of Oregon, described as follows, to-wit:

Beginning at a point 1280 feet East and 1080 feet North of the section corner common to Sections 19, 20, 29, 30; thence North 151.7 feet; thence West 150 feet; thence South 151.7 feet; thence East 150 feet to the point of beginning, all in Section 20, Twp. 38 South, Range 9, E.W.M.

Subject to an easement for parking purposes in favor of the following-described real property: Beginning at a point 1230 feet East and 1080 feet North of the section corner common to Sections 19, 20, 29 and 30; thence North 151.7 feet to the true point of beginning; thence North 110 feet; thence West 150 feet; thence South 110 feet; thence East 150 feet to the point of beginning, all in Sec. 20, Twp. 38 S., R. 9, E.W.M.; and Beginning at a point 1280 feet East and 1080 feet North of the section corner common to Sections 19, 20, 29 and 30; thence North 261.7 feet; thence West 150 feet to the true point of beginning; thence West 121 feet; thence South 261.7 feet; thence East 121 feet; thence North 261.7 feet to the point of beginning, all in Sec. 20, Twp. 38S., R. 9, E.W.M.

To Have and to Hold the same unto the said grantee and grantee's heirs, successors and assigns forever.

And said grantor hereby covenants to and with said grantee and grantee's heirs, successors and assigns, that grantor is lawfully seized in fee simple of the above granted premises, free from all encumbrances, except charges and assessments of the City of Klamath Falls for monthly water and/or sewer service; Reservations, restrictions, easements and rights of way of record and those apparent on the land, if any,

and that grantor will warrant and forever defend the said premises and every part and parcel thereof against the lawful claims and demands of all persons whomsoever, except those claiming under the above described encumbrances.

The true and actual consideration, paid for this transfer, stated in terms of dollars, is \$ 25,000.00
