COVENANTS OF GRANTOR.

JUSSITO protect the security of this Trust Deed, Grantor agrees as follows:

- 1.1. Maintenance of the Property. Grantor agrees to maintain the Property in good condition at all times. Grantor shall promptly make all necessary repairs, replacements and renewals so that the value of the Property shall be maintained, and Grantor shall not commit or permit any waste on the Property. Grantor will not permit any portion of the Property to be used for any unlawful purpose. Grantor will comply promptly with all laws, ordinances, regulations and orders of all public authorities having jurisdiction thereof relating to the Property or the use, occupancy and maintenance thereof. Grantor shall not materially alter the buildings, improvements, fixtures, equipment or appliances now or hereafter upon the Property or remove the same therefrom, or permit any tenant or other person to do so, without the written consent of the lender.
