DESCRIPTION

The following described real property situate in Klamath County, Oregon:

All those parts of the SW4NE4 and NW4SE4 of Section 21, Township 39 South, Range 9 East of the Willamette Meridian, Klamath County, Oregon, which lies Northeasterly of the Northeasterly boundary of the right of way of Lost River Diversion Canal.
