

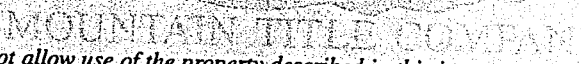
KNOW ALL MEN BY THESE PRESENTS, That JUANITA B. BLUMEL

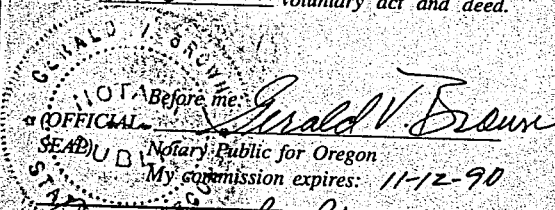
