hereinafter called the "Borrower(s)" and WESTERN BANK, an Oregon banking corporation, hereinafter called the "Bank":

____ 19_78___ the Borrower(s) (or the original WITNESSETH: On or about the <u>3rd</u> day of <u>January</u> maker(s) if the Borrower is an assignee of record) did make, execute and deliver to the Bank that certain promissory note in the sum of \$_450,000.00_ payable in monthly installments with interest at the rate of _9,50 % per annum. For the purpose of securing the payment of said promissory note, the Borrower(s) (or the original maker(s) if the Borrower is an assignee of record) did make, execute and deliver to the Bank their certain Mortgage or Trust Deed, hereinafter called a 19.78 conveying the following described real "Security Instrument" bearing date of January 3 to-wit: State of Oregon property, situate in the County of <u>Klamath</u>

Lots 23 and 24 Block 309 DARROW ADDITION, According to the official plat thereof on file in the office of the County Clerk of Klamath County, Oregon

which Security Instrument was duly recorded in the records of said county and state.

There is now due and owing upon the promissory note aforesaid, the principal sum of <u>Two Hundred Sixteen Thousand</u> DOLLARS (\$*216,254.25**__) Two: Hundred Fifty Four and 25/100 * ***** together with the accrued interest thereon, and the Borrower(s) desire a modification of the terms of payment thereof, to which the Bank is agreeable on the terms and conditions hereinafter stated and not otherwise.

NOW THEREFORE, in consideration of the premises and of the promises and agreements hereinafter contained, the parties hereto do hereby agree that the balance now due and owing on the promissory note hereinabove described shall be and DOLLARS (\$ <u>**3,000.00**</u>) each, <u>including</u> interest on the unpaid balance at the rate of <u>9.50</u>% per annum. The first installment shall be and is payable on the <u>3rd</u> day of <u>June</u> 19_89, and a like installment shall be and is payable on the <u>3rd</u> day of each month thereafter until the principal and interest are fully paid, except that the final payment of principal and interest if not sooner paid, shall be due and payable on the 3rd 19_91_. If any of said installments or either principal or interest are not so paid, the entire balance then owing shall, at the option of the Bank or its successors in interest, become immediately due and payable without

Except as herein modified in the manner and on the terms and conditions herein stated, the said promissory note and notice. Security Instrument shall be in full force and effect, with all the terms and conditions of which the Borrower(s) do agree to comply in the same manner and to the same extent as though the provisions thereof were in all respects incorporated herein and made a part of this agreement.
