TO ALL PEOPLE TO WHOM THESE PRESENTS SHALL COME, GREETINGS;

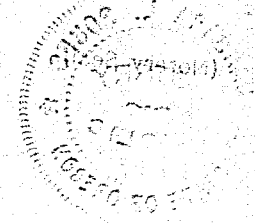
KNOW YE, THAT WE, James Arraj and Tyra T. Arraj,

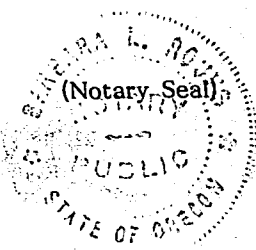
