C.U.P. Case No. 20-82 FINDINGS OF FACT, CONCLUSIONS OF LAW AND ORDER

THIS MATTER came before Deputy Hearings Officer Michael C. Miller on May 18, 1989 in the Klamath County Commissioners' Hearing Room. The applicant was present and represented herself. The Klamath County Planning Department was represented by Mr. J. Kim Lundahl, and there was no Recording Secretary. The Klamath County Planning Department's file and all contents thereof were The Deputy Hearings incorporated into the record as evidence. Officer, after reviewing the evidence presented, makes the following Findings of Fact, Conclusions of Law and Order:

FINDINGS OF FACT:

1. The applicant is seeking a two-year extension of time in which to complete development of an RV park which was the subject of Conditional Use Permit 20-82.

The applicant has caused approximately 75,000 cubic 2. yards of gravel to be removed from the proposed pond site which will be a major attraction of the facility. The applicant proposes to remove another 25,000 yards of gravel during the spring and summer of 1989.

3. The applicant testified that the completion of the pond excavation will be a major step in her development plan. The remaining steps include building of restrooms and a recreation room.

FINDINGS OF FACT, CONCLUSIONS OF LAW AND ORDER -1-

CONCLUSION AND ORDER:

1. The applicant has made substantial development of the proposed RV facility.

2. The applicant's efforts to date warrant a two-year extension in which to complete the development.
