WARRANTY DEED-SURVIVORSHIP

KNOW ALL MEN BY THESE PRESENTS, That Robert Pieruccini

for the consideration hereinafter stated to the grantor paid by Robert Pieruccini and Loren L. Lasher

hereinafter called grantees, hereby grants, bargains, sells and conveys unto the said grantees, not as tenants in common but with the right of survivorship, their assigns and the heirs of the survivor of said grantees, all of the following described real property with the tenements, hereditaments and appurtenances thereunto belonging or in any wise appertaining, situated in the County of Klamath, State of Oregon, to-wit:

The North Half of Lot 6 Block 3 Second Addition to Altamont Acres.

With the intention of creating an Estate by the entirety.

grantor will warrant and forever defend the said premises and every part and parcel thereof against the lawful claims and demands of all persons whomsoever, except those claiming under the above described encumbrances.
