WHEREAS, James Olson made and entered into an agreement with Klamath County on March 15, 1988 for the purchase of a portion of the SW 1 NW1 of Section 10, Township 25, Range 11 EWM, tax lot number R3511-01000-00700, for the sum of One Thousand Seven Hundred Fifty Dollars (\$1,750.00), with the sum of Three Hundred Eighty Dollars and Sixty-two Cents (\$380.62) being due on March 15, 1989; and

WHEREAS, James Olson has not paid the real property taxes which became due on November 15, 1988 as required by the contract nor has he paid the payment due on March 15, 1989; and

WHEREAS, the Commissioners office mailed to James Olson, at his address and at a forwarding address, two notices of said payment and the certified mail was returned unclaimed; and

WHEREAS, no contact has occurred since that time and the contract is now in default;

NOW, THEREFORE, IT IS HEREBY ORDERED that the Contract between Klamath County and James Olson dated March 15, 1988 is hereby cancelled. A certified copy of this Order shall be mailed by Registered Mail, Return Receipt Requested, to James Olson at his last two (2) known addresses.
