NOTICE HEREBY IS GIVEN That DONALD R. MANNING and LILLIAN V. 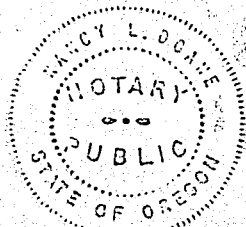
