## Notice of Location of Placer Claim

STATE of OREGON, County of Klamath Mining District.

**NOTICE HEREBY IS GIVEN** That the undersigned locators, each a citizen of the United States or one who has declared an intention to become such, have discovered a placer deposit of locatable minerals upon the public domain of the United States which is open to mineral entry and location within the above state, county and mining district; and, in accordance with the laws of the United States and the State of Oregon, have located and hereby do locate a placer claim of 1.60 acres by posting this notice of location on a post or monument in a conspicuous place inside the boundaries of the claim. The claim is named the MGSE #1 (One).

(1) If claim is on surveyed land:

This claim comprises the East  $\frac{1}{2}$  (half) of the East  $\frac{1}{2}$  (half) withdrawn from of Section 4 (four), Township 32 South, Range 7 $\frac{1}{2}$  East, of the Willamette Meridian, 14, the State of Oregon.
