DESCRIPTION OF PROPERTY ASSIGNED FOR RIGHT OF REDEMPTION

The N $\frac{1}{2}$ NW $\frac{1}{4}$ of Section 8, Township 41 South, Range 12 East of the Willamette Meridian, lying North of the U.S.R.S. Canal in Section 8, in the County of Klamath, State of Oregon, SAVING AND EXCEPTING that portion more particularly described as follows:
