KNOW ALL MEN BY THESE PRESENTS, That Patscheck-Veiga Development Inc.

Inglis, husband and wife, hereinafter called the grantee, does hereby grant, bargain, sell and convey unto the said grantee and grantee's heirs, successors and assigns, that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or appertaining, situated in the County of Klamath and State of Oregon, described as follows, to-wit:

Parcel 1: The North West 1/4 of the South East 1/4 of the South West 1/4 of Section 19, Township 32 South Range 8, East Willamette Meridian, consisting of ten acres, more or less.

Excluding therefrom the Easterly 30 feet as a non-exclusive easement for the purpose of ingress and egress.

Parcel 2: The South West 1/4 of the South East 1/4 of the South West 1/4 of Section 19, Township 32, South Range 8, East Willamette Meridian, consisting of ten acres, more or less.

Excluding therefrom the Easterly 30 feet as a non-exclusive easement for the purpose of ingress and egress

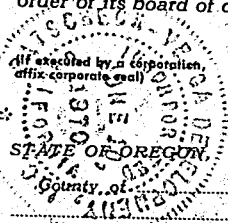

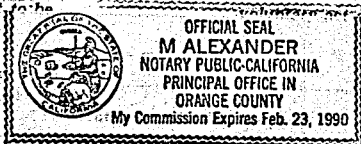
