ELECTRIC LINE RIGHT-OF-WAY EASEMENT

KNOW ALL MEN BY THESE PRESENTS that for a good and valuable consideration GILCHRIST TIMBER COMPANY, a corporation (hereinafter "Gilchrist"), does hereby grant unto MIDSTATE ELECTRIC COOPERATIVE INC., a cooperative (hereinafter "Cooperative"), and to its successors and assigns a right-of-way easement to enter upon the following described lands in Township 24 South, Range 9 East, in Klamath County, Oregon, to wit:

SW 1/4 of Section 17 S 1/2 of Section 18 W 1/2 of Section 19

and to replace the existing transmission line, all as shown on the attached drawing. Such right shall include the right to inspect and make such repairs, changes, alterations, improvements, removals from, substitutions, and additions to such transmission line as Cooperative may from time to time deem advisable; to cut, trim, and control the growth by machinery or otherwise of trees and shrubbery located within 40 feet of the centerline of said line, or that may otherwise interfere with or threaten to endanger the operation and maintenance of said line; to keep the easement clear of all buildings, structures, or other obstructions.

Such essement shall continue so long as Cooperative or its successors and assigns maintains and uses said replaced transmission line. Upon the termination of such use, this easement shall terminate and be of no further force and effect

and Cooperative or its successors or assigns forthwith shall remove all its property and deliver to Gilchrist a quitclaim deed releasing its interest in the above-described property.

Gilchrist agrees that all poles, wires, and other facilities installed in, upon, or under the above-described lands at the Cooperative's expense shall remain the property of Cooperative, removal at the option of Cooperative.


