The NE $\frac{1}{4}$ NW $\frac{1}{4}$  Section 25, T.35S., R.11E., W.M.


the location of said facilities to be as generally delineated on Exhibit "A" attached hereto and made part hereof.

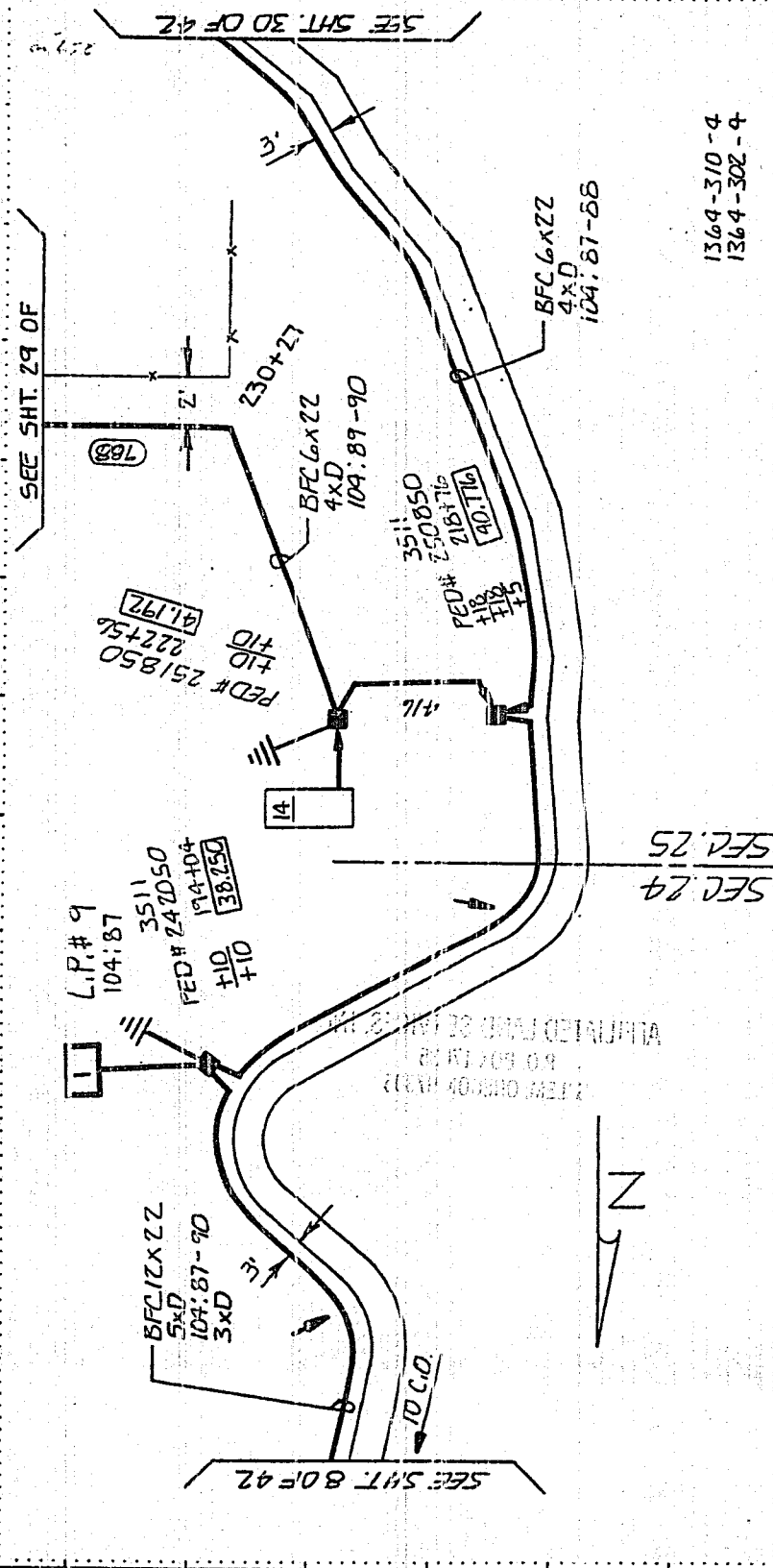

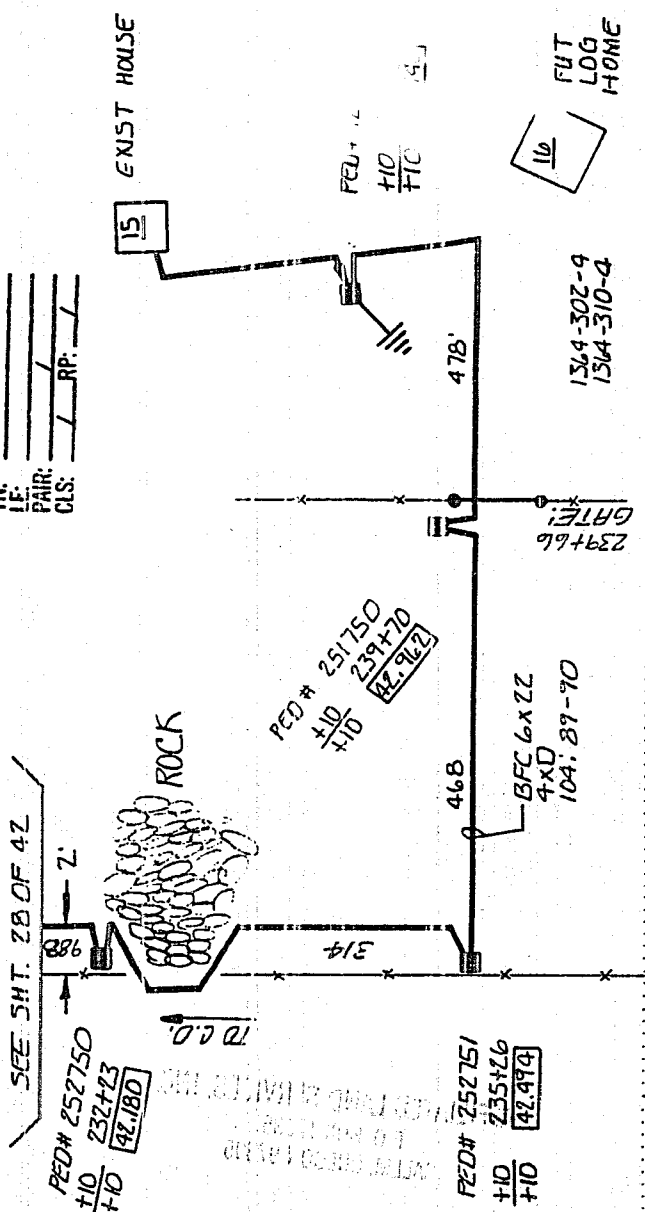


