## AGREEMENT TO FERMINATE FARM LEASE BY MUTUAL CONSENT

Agreement made on April 30, 1989, between FACILITIES LEASING CORPORATION, herein referred to as "Lessor", and BRIER SPRINGS HEREFORDS, a partnership consisting of J. Anthony Giacomini and Sydney K. Giacomini, herein referred to as "Lessee"

## WITHESSETH:

RECITALS: The parties recite as follows:

1. Lessor and Lessee are parties to a Farm Lease dated April 1, 1975, by which Lessor demised to Lessee for the period from April 1, 1975, to and including March 31, 1995, the premises located in Klamath County, Oregon, described in that certain Memorandum of Farm Lease dated April 1, 1975, recorded July 21, 1975, in Vol. M-75, page 8285, Deed Records of Klamath County, Oregon. Reference to the recorded Memorandum of Farm Lease is made for the description of the real property described in it.

The parties desire to terminate and cancel the Farm Lease and the tenancy as of April 30, 1989, and to release each other from their respective obligations under the Farm

The Farm Lease shall be and hereby is terminated and cancelled and the term 1. **~**~ thereof is brought to an end as of April 30, 1989, with the same force and effect as if the a term of this Farm Lease were, by the terms thereof, fixed to expire on April 30, 1989, and not on March 31, 1995, as provided in the Farm Lease, subject to the terms and conditions set forth below.

2. Lessor and Lessee are released and discharged from their respective obligations S to observe the terms and conditions of the Farm Lease on their respective parts to be S observed.

3. Lessee shall vacate the premises on or before April 30, 1989.

All of the terms and conditions herein contained shall be binding on and inure to 4. the benefit of the parties, and the respective heirs, legal representatives, successors, and assigns of the parties,
