

## AMENDMENT TO SHARED WELL AGREEMENT

It is agreed that said well to be used for domestic purposes only for Parcel # 2. Parcel # 1 shall not be restricted as to use of well as long as it does not diminish domestic water use for parcel # 2.

Parcel # 2 shall be responsible for any costs in maintaining or repairing water pipes from well to that residence.

All rights to well remain with parcel # 1 except as stated in the Well Agreement and the today signed amendment.

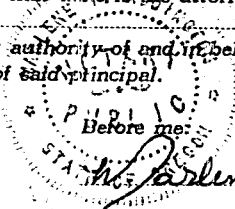

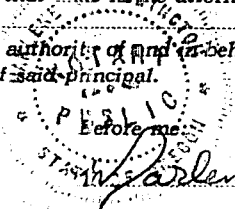
