FINDINGS OF FACT, CONCLUSIONS OF LAW AND ORDER

THIS MATTER came before Deputy Hearings Officer Michael C. Miller on August 3, 1989 in the Klamath County Commissioners' Hearing Room. The hearing was held pursuant to notice given in conformity with the Klamath County Land Development Code and related ordinances. Robert Masterson was present and represented himself. The Klamath County Planning Department was represented by Mr. J. Kim Lundahl and there was no Recording Secretary. The Klamath County Planning Department file and all contents thereof were incorporated into the record as evidence. The Deputy County Hearings Officer, after reviewing the evidence presented, makes the following Findings of Fact, Conclusions of Law and Order:

## FINDINGS OF FACT:

1. Robert Masterson indicated a desire to remove the subject vehicles. He further indicated he did not have the titles to the vehicles and the wrecking yards would not accept the vehicles without the titles. Mr. Masterson said he intended to deliver the vehicles to the automobile crusher which was expected in Klamath Falls in about sixty days.

## CONCLUSION AND ORDER:

1. Robert Masterson is found to be in violation of the Klamath County Land Development Code by permitting an automobile wrecking yard as defined in Section 93.005 J in a zone which does not permit that use.

2. Imposition of sanctions is stayed on condition that the property owner remove the wrecked and inoperable vehicles in a legal manner from the subject property on or before October 1, 1989.
