KNOW ALL MEN BY THESE PRESENTS, That the undersigned trustee or successor trustee under that certain trust deed dated February 16, 1988, executed and delivered by Larry Eugene Peterman and Nancy Ann Peterman, aka Larry E. Peterman\* as grantor and recorded on February 17, 1988 in the Mortgage Records of Klamath County, Oregon, in book/reel/volume No. M88 at page 2236, or as document/file/instrument/microfilm No. 84423 (indicate which), conveying real property situated in said county described as follows:

## PARCEL 1:

A tract of land situated in the NE¼ of Section 24, Township 39 South, Range 9 East of the Willamette Meridian, more particularly described as follows:

Beginning at a point located West a distance of 1072.7 feet and South 0° 19' West a distance of 30.0 feet from the iron axis marking the Northeast corner of said Section 24, said beginning point being located on the South boundary of Airway Avenue; thence South 0° 19' West a distance of 166.4 feet to the Northerly boundary of the USRS Dixon Drain; thence along the Northerly boundary of said drain North 75° 18' West a distance of 96.9 feet and South 44° 26' West a distance of 248.9 feet; thence leaving the Northerly boundary of said drain North 0° 19' East a distance 319.5 feet to the South boundary of Airway Avenue; thence East along the South boundary of Airway Avenue a distance of 267.05 feet, more or less, to the point of beginning.

## PARCEL 2:

A tract of land situated in the NE¼ of Section 24, Township 39 South Range 9 East of the Willamette Meridian, more particularly described as follows:

Beginning at a point located West a distance 953.1 feet and South 0° 19' West a distance of 30.0 feet from the iron axis marking the Northeast corner of said Section 24, said beginning point being on the South boundary of Airway Drive; thence South 0° 19' West a distance of 197.8 feet to the Northerly boundary of the USRS Dixon Drain; thence North 75° 18' West along the Northerly line of said drain, a distance of 123.6 feet; thence North 0° 19' East a distance of 166.4 feet to the South boundary of the Airway Drive; thence East along the South boundary of Airway Drive 119.6 feet, more or less to the point of beginning.

having received from the beneficiary under said trust deed a written request to reconvey, reciting that the obligation secured by said trust deed has been fully paid and performed, hereby does grant, bargain, sell and convey, but without any covenant or warranty, express or implied, to the person or persons legally entitled thereto, all of the estate held by the undersigned in and to said described premises by virtue of said trust deed.
