This power shall take effect: (delete inapplicable phrase)

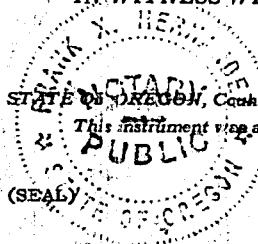
(a) on the date next written below;
