NOTICE HEREBY IS GIVEN That Basin Fertilizer & Chemical Co. claims a lien upon the potato crops of DONALD C. ROHRBACKER grown in the year 1989 upon the following described farmland, range, ranch, orchard land or in claimant's place of business situated in Klamath County, Oregon, more particularly described as a portion of Tax Lot No. 41-11-06-100 (30 acres) and a portion of Tax Lot No. 41-11-05-600 (36 acres) owned by Vlasta Petrick, and a portion of Tax Lot No. 41-11-06-800 (23 acres) and a portion of Tax Lot No. 41-11-06-500 (22 acres) owned by Harry M. Paschke, all located in Klamath County, Oregon.

Said lien also is claimed upon the proceeds of the sale of any or all of said crops. For brevity, the crops charged with this lien hereinafter are called chattels.

Said lien is claimed for labor performed, materials supplied and/or services provided (as hereinafter more particularly described) by claimant at the request and for the benefit of the owner of said chattels to aid the growing or harvesting of crops; the words "performs labor or provides services," "materials," and "growing and harvesting" as used in this lien have the meaning ascribed to them in ORS 87226(3), to which reference hereby is made.

The said labor, materials and/or services consisted of fertilizer and chemicals.

The name of the owner of the chattels so charged with this lien is: Donald C. Rohrbacker.

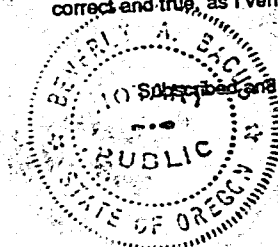
