The applicants' request for a variance to reduce the front yard setback from 25' to 16' and side yard setback from 5' to 2' is hereby granted on condition that the applicants take steps, including but not limited to, the placement of rain gutters on the south edge of the proposed carport to ensure that

runoff from the carport and mobile home does not burden the adjacent property.
