(whose Birthdate(s) and Driver's License Number(s) are not available to the District Clerk) No. V 438,298, on the docket of such Court, a judgment was entered in favor of the State of Texas and the Texas Employment Commission against Hallmark Graphics, a partnership; and Don and Nancy Shindler whose address appears as: 820 Pacific Terrace, Klamath Falls, OR 97601

The judgment was for the sum of 1,270.09 dollars, this representing contributions and penalties as of the 31st day of March, 19 87, as shown by the following schedule:

Said judgment provides that penalty imposed by Subsection 12(a), Art. 5221b, V.C.S. shall be due on the contributions shown above from the date of delinquency until paid at the rate of 1.0% per month, until September 30, 1982, and at the rate of 1.5% after September 30, 1982, provided that such penalty on contributions for any one calendar quarter shall not exceed 25%, and for \$ 238.00 costs of suit; said judgment is of record in Vol. 1762 Page 833, Minutes of Said Court.

There is still due on said judgment \$ 1,270.09 with penalty on contributions imposed by Subsection 12(a), Art. 5221b, V.C.S. for each quarter from 1st day of April, 19 87, at the rate of 1.0% per month until September 30, 1982, and at the rate of 1.5% after September 30, 1982, until paid or until a maximum of such penalty of 25% is reached for each quarter, and thereafter such judgment shall bear interest at the rate of 0.5% per month; together with \$ 238.00 costs of suit.
