OBSECUNIFORM COVENANTS. Borrower and Lender covertant and agree as follows:

1. Payment of Principal and Interest; Prepayment and Late Caarger. Borrower shall promptly pay when due the principal of and interest on the debt evidenced by the Note and any prepayment and late charges due under the Note.

2. Funds for Taxes and Insurance.
