A parcel of land situate in the $NW_{1}^{1}NW_{1}^{1}$, Section 3 Township 39 South, Range 9 East of the Willamette Meridian, Klamath County, Oregon, more particularly described as follows:

Commencing at the section corner marking the NW corner of Section 3, Township 39 South, Range 9 East of the Willamette Meridian, Klamath County, Oregon, and running thence S. 0°00'30" E. along the Westerly boundary of said Section 3, 826.8 feet, more or less, to its intersection with a line parallel with and 75 feet distant at right angles Northeasterly from the centerline of the Dalles-California Highway, also known as South Sixth Street, as the same is now located and constructed; thence S. $55^{\circ}52\frac{1}{2}$ ' E. along said parallel line 36.2 feet, more or less, to a point in the line marking the Easterly boundary of Washburn Way, as the same is now located and constructed, which point is the true point of beginning of this description, running thence S. $55^{\circ}52\frac{1}{2}$ ' E. along said parallel line 296.92 feet, more or less to a point, thence N. $34^{\circ}07'30"$ E., 175 feet, more or less, to a point on the Southwesterly right of way line of Pershing Way; thence N. $55^{\circ}52'30"$ W. along said right of way line a distance of 402.52 feet, more or less, to its intersection with the Easterly right of way line of Washburn Way, thence S. $0^{\circ}00'30"$ E. along said right of way line 211.4 feet, more or less, to the true point of beginning.
