# NATURE OF THE APPLICATION

A hearing on this application was held September 26, 1989, pursuant to notice given in conformity with Ordinances No. 44 and 45.

The hearing was held before the Klamath County Planning Commission. The request to establish a mineral extraction site for sand and gravel in the Forestry zone was considered pursuant to Section 51.020 and Article 81 of the Land Development Code.

# 2. NAMES OF THOSE INVOLVED

The applicant was represented by Dennis Brant of Weyerhaeuser Co. The Planning Department was represented by Kim Lundahl, Senior Planner. The recording secretary was Karen Burg. Michael L. Spencer, County Counsel, was present to offer legal assistance.

## 3. LEGAL DESCRIPTION

The subject property is located in sections 32 and 33, Township 36 south, Range 7 east, W.M.. Generally located between Howard Bay and State Hwy 140.

The area within the parcel is 126 acres.

### 4. RELEVANT FACTS

The property is within the Forestry Plan designation with an implementing zone of Forestry. The operation site is 126 acres in size and is under Forestry tax deferral.

#### 5. FINDINGS

All evidence submitted as the staff report, exhibits A-J, and offered testi-

mony show that the approval criteria as set out in the code has been satisfied. The Commission finds this application conforms with the criteria set out in L.D.C. section 51.020 E as follows:

A. The proposal is compatible with forest uses, because; The mineral to be extracted from this site is sand and gravel for use on forestry roads as well as commercial sale for State, County, and private uses. The project compliments forestry operations by providing a much needed material for concrete and other surfacing uses. The site is of moderate timber productivity due to the gravelly soil. A lagoon will result from the quarry operations. Wildlife enhancement, a forestry use, will be enhanced by the planting of cover and food species. The Planning Commission finds this to be of beneficial to forest uses as they pertain to wildlife.

B. The proposal does not interfere seriously with the accepted forestry practices on adjacent lands devoted to forestry use; and does not significantly increase the cost of forestry operations on such lands. because; Because of the nature parcel configuration, a narrow parcel lying between Hwy 140 and Howard Bay, minimal loss of productivity is anticipated and minimal impact to forest operations across Hwy 140 will occur. Costs of managing the Klamath Tree Farm will not be negatively affected. Road surface material for forestry road maintenance will also be made available.

C. The project will not materially alter the stability of the overall land use pattern of the area, because;

The surrounding land use is Forestry, with the applicant being the principal land owner. The area is suitable for low production tree crops; however, the commission finds that due to the limited availability of gravel and sand<sup>o</sup>

resources the use of the property for a quarry activity outweighs its use for tree production. The Planning Commission finds that other forest uses as set out in the Goal will not be compromised by this activity.

D. The site is located on generally unsuitable land for the production of forest products and livestock, considering the terrain, adverse soil or land conditions, drainage and flooding, vegetation, location and size of the tract, because; the site is suitable for forest use it will be reclaimed for forest uses upon the cessation of mining operations.

E. The mineral extraction site considers site productivity, minimizes the loss of productive forest lands; and is limited to the area suitable and appropriate to the needs of the proposed use, because; the planned size, shape, and reclamation of the area will minimize the long term loss of productive lands. The site class for the project site is 65. The site productivity lost over the lifespan of the quarry would be 800 c.c.f.. The enhancement of the area for bird species outweighs the loss of tree production over this period.

F. The project meets the standards set forth relating to the availability of fire protection and other rural services and will not tax those services because; fire protection is provided through contract with the Oregon Dept. of Forestry. No other utilities/services are required by this project.

## 6. CONCLUSIONS AND ORDER

The Planning Commission finds the applicant has satisfied the pertinent review criteria in that correct notice was given, all relevant code and policy have been complied with, and that the intent of Goal 4-Forestry Lands has not been compromised.

Therefore, it is hereby ordered the request for Conditional Use Permit 39-89 is approved subject to the following:

1. This operation will be operated in conformance with applicable local/state/federal regulations.

2. This operation will not commence until a D.O.G.A.M.I. approved reclamation plan, with consultation with Oregon Department of Fish and Wildlife concerning the advisability of opening the resulting ponds to the lake flow, is on file with the Planning Department.

3. A "buffer strip" 200 feet wide will be maintained on the east side of State Hwy 140 to screen the extraction site.
