KNOW ALL MEN BY THESE PRESENTS, That the undersigned, for the consideration hereinafter stated,

has sold and assigned and hereby does grant, bargain, sell, assign and set over unto

HAROLD A. STURGEON and HAZEL L. STURGEON, husband and wife,

their ~~xxx~~ heirs, successors and assigns, all of the vendee's right, title and interest in and to that certain contract for the sale of real estate dated

January 14, 1983, between JOHN M. HOFFMAN, JOHN R. HATHAWAY and MAUDELE HATHAWAY

as seller and DONALD LEE STEERS and HAZEL FERN STEERS, husband and wife,
