# 1. NATURE OF THE REQUEST:

The applicant wishes to partition 229.41 acres into two parcels of approximately 133.95 and 95.46 acres in size. This request was heard by the Planning Commission on October 24, 1989, pursuant to Article 25 and reviewed for conformance with Land Development Code Section 51.017(E).

# 2. NAMES OF THOSE WHO PARTICIPATED:

The applicant appeared and offered testimony in support of the application. The Planning Department was represented by Carl Shuck, Planning Director. The recording secretary was Karen Burg. Legal assistance was given by Michael L. Spencer, County Counsel. There was a quorum of the Planning Commission present.

# 3. LEGAL DESCRIPTION:

The subject property is located in Sections 28 and 33, Township 40S, Range lOEWM, located off Chin Road approximately 1/4 mile south of Chin Road and State Highway 39.

## 4. <u>RELEVANT FACTS</u>:

The property is within the Agriculture plan designation and has an implementing zone of EFU-C. The property is 229.41+/- acres in size and is under Farm Deferral.

#### 5. FINDINGS:

A. All evidence submitted, Exhibits A-E, and offered testimony by the applicant shows compatibility with existing uses in the surrounding area.

Parcels of lesser size, -95 acres are located to the immediate boundaries. Historic use of the property has been agriculture related, cropland, and pasture. Contiguous land uses are identical, EFU, and the proposed use will not conflict with existing uses.

B. The proposal will not interfere with existing uses.

C. The project can maintain an agricultural use due to soil type, irrigation methods and topography.

D. That the minimum parcel size, 95 acres, exceeds 80 acres as identified in Section 51.017(E)(1)(a)(3).

E. That the subject property is in deferral under ORS 208.372 as submitted by applicant.

F. That the proposal meets the standards set forth relating to the availability of fire protection, County Fire Dist. No. 1, and will not tax these services.
