KNOW ALL MEN BY THESE PRESENTS, That **Lorene Galbreath**, hereinafter called grantor,

for the consideration hereinafter stated, does hereby remise, release and quitclaim unto **Patricia L. Royer** hereinafter called grantee, and unto grantee's heirs, successors and assigns all of the grantor's right, title and interest in that certain real property with the tenements, hereditaments and appurtenances thereunto belonging or in anywise appertaining, situated in the County of **Klamath**, State of Oregon, described as follows, to-wit:

The southerly half of the following described property to-wit: Beginning at a point 1073.5 feet North of a point 308.7 feet West of the corner of Townships 39 and 40 South, Ranges 7 and 8 East of the Willamette Meridian, Oregon; thence North 208.7 feet; thence West 208.7 feet; thence South 208.7 feet; thence East 208.7 feet to the place of beginning, containing 1 acre, being a portion of Section 36, Township 39 South, Range 7 East of the Willamette Meridian, the property conveyed containing $\frac{1}{2}$ acre, more or less, in Klamath County, Oregon.

To Have and to Hold the same unto the said grantee and grantee's heirs, successors and assigns forever.
