EXHIBIT "A" LEGAL DESCRIPTION

A parcel of land situate in the Southeast quarter of the Northwest one-quarter of Section 1, Township 39 South, Range 9 East of the Willamette Meridian, Klamath County, Oregon, being more particularly described as follows:
