NOTICE OF DEFAULT AND ELECTION TO SELL

Reference is made to that certain trust deed made by Antonio Aguon Aguera, A single man

as grantor, to  
ASPEN TITLE & ESCROW, INC., An Oregon Corporation, as trustee,  
in favor of F. N. REALTY SERVICES, INC., A California Corporation, Trustee, as beneficiary,  
dated July 20, 1988, recorded December 20, 1988, in the mortgage records of
