CERTIFICATE OF DISCHARGE OF PROPERTY FROM FEDERAL ESTATE TAX LIEN

The estate of June F. Grimes identifying number 543-42-8606, is indebted to the United States for unpaid Internal Revenue tax in the sum of Forty nine thousand, eighty nine and no/100 dollars (\$49,089.00) specifically, Federal estate tax imposed by Chapter 11 of subtitle B of the Internal Revenue Code.

To ensure the collection of said tax, notice of the lien of the United States was filed with the County Clerk for the County of Klamath on March 10, 1982.

The lien of the United States for said tax attached to certain property described as:

A tract of land described as follows: Beginning at the quarter corner common to Sections 15 and 16, Township 39S, Range 10 E.W.M.; thence West along the East-West quarter line a distance of 123 feet to a point; thence South parallel to the East line of said Section 16 to a point on the Northerly right-of-way line of Klamath Falls-Lakeview Highway; thence Southeasterly along the said Northerly right-of-way line to its intersection with the East line of said Section 16; thence North along the East line of said Section 16 to the point of beginning; said tract being located in the E 1/2 of the E 1/2 of the NE 1/4 of the SE 1/2 of Section 16, Township 39 S., Range 10, E.W.M., in Klamath County, Oregon.

The District Director of Internal Revenue has determined that the certificate of discharge is being issued with respect to the property described above because the liability has been provided for.

Therefore, I, Carolyn Leonard, District Director of Internal Revenue at Portland, Oregon, do discharge the property described above from the tax lien identified above, reserving, however, the force and effect of the tax lien against any other property, wherever situated, to which the lien attaches.
