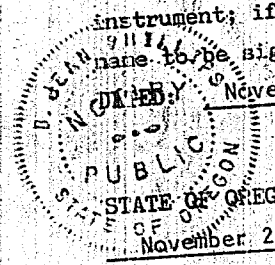
DEED OF RECONVEYANCE
