Addendum of Agreement To Use Water Well

David Bowen the current Grantor and the future Grantors of Lot 10 Block 3 of Tract 1155, Twin River View and Charles Gebhart/Muray Gebhart and the future Grantees of Lot 11 Block 3 of Tract 1155, Twin River View, are to enter into this addendum agreement to seperate the power to the well that is servicing both parcels. When the Grantors of Lot 10 Block 3 of Tract 1155, Twin River View, starts to use the well, the well is to have its own Electric Meter and the Grantors and Grantees are to share the expence of the Electric Bill equally. If the usage of the well is not used equally, then the Grantors and Grantees will install Water Meters and prorate the Electric Bill by the volume of water used.
