MODIFICATION AGREEMENT

WHEREAS, BROOKS RESOURCES CORPORATION, executed and delivered to RUTH H. TEASDEL, a promissory note in the amount of \$1,200,000.00 with interest thereon at the rate of 8.00%, payable in monthly installments of not less than \$11,472.00, and a Mortgage recorded April 20, 1979, in Volume M79, Page 8893, mortgage records of Klamath County, Oregon, to secure said note for the purchase of that certain land described in said mortgage;

WHEREAS, the parties hereto have agreed to modify the terms of the promissory note and mortgage;
